


ESTABLISHMENT CERTIFICATE

2. IMPLEMENTATION OF RTE ACT :

Reference CBR No. 02 dated 18.02.2011.

To consider the implementation of RTE Act for the forthcoming academic session starting from 01.04.2011 in the Cantonment Board Primary Schools that

- i) As per the RTE Act, free education is to be given to the children of 6 to 14 years of age.
- ii) English Medium is started in 03 Cantonment Board Primary Schools for Nursery & Ist class on CBSE pattern. The schools may now be renamed Cantt. Board Elementary School instead of Primary school.
- iii) For the purpose of Elementary education, 6th class will be started in Topkhana Parade & B.I.Bazar School. Pending sanction of command contractual teachers be hired against vacant posts by the CEO to start the academic session.
- iv) Admission will be given on first come basis.
- v) Free learning material shall be required given to all the students.

The file, alongwith other relevant documents, is placed on the table.


RESOLUTION No. 2 :

6. UPGRADATION OF CB MIDDLE SCHOOL TO CB HIGH SCHOOL.

To consider the matter regarding upgradation of the Cantonment Board Middle Schools, RHA Parade and B.I Bazar up to High School i.e. 10th Class from the academic session 2023-2024.

During the annual inspection of Cantonment Board, Ambala in the month of July, 2022 by Sh. Yogesh Kumar, Director, DE, WC Chandigarh and Cleanliness & Vigilance Inspection in the month of November, 2022 by Sh. Ompal Singh, Dy. Director, DE, WC Chandigarh it is suggested by them to upgrade the standard of schools.

During the visit of the Principal Director, DE, WC, Chandigarh in the month of December, 2022 appreciated the infrastructure of the schools and the quality/ standard of the school, advised to upgrade the school of the Cantonment Board, Ambala and also directed to initiate the necessary steps for the participation of the students of the Cantonment Board Schools in the different programs, activities, sports etc. with the State Govt. Schools.

Presently, the status of the schools is as under:



Presently, there is a sufficient space/infrastructure in the schools to introduce the new classes i.e. 9th class from the academic session 2023-2024. The Cantonment Board, Ambala is in position to start 9th class from session 2023-2024 and 10th class from the session 2024-2025. This step of Cantonment Board will be very beneficial to the children of the residents of the Cantonment area and very helpful to improve the standard and quality of education of the Cantonment Board, Schools. There is a sufficient provision of the amount in the budget estimates for the year 2023-2024 (original) to incur the necessary expenditure.

25. UPGRADATION OF C.B. HIGH SCHOOL, RHA PARADE, AMBALA CANTT.

Reference CBR No. 06 dated 08.02.2023.

The Board was upgraded two Cantonment Board Middle Schools as High School in RHA Parade and B.I. Bazar from the Academic Session 2023-24 vide CBR referred above. Presently 960 Nos. of students in C.B. High School, RHA Parade. Out of these 66 Nos. of students are studying in 10th class. As per report of Principal, there is a demand/requirement to upgrade the school as Senior Secondary School by starting 10+1 from the ensuing academic session 2025-26 in the Humanities and Commerce stream. There will be requirement of extra rooms and additional teaching staff from the new academic session for smooth functioning of school.

RESOLUTION NO. 25: Considered and approved. Further resolved that CEO is authorized to take necessary action to start 10+1 in Humanities and Commerce stream from the new academic session 2025-26. Additional teaching and non-teaching staff as per actual requirement be engaged from the existing contractor and to initiate necessary action for the extension of infrastructure and to procure the necessary equipment, furniture etc.
